WARRANTY LIMITATIONS

The aforementioned warranty does not apply if:

- a) the seller is not an authorised SunTek® dealer for architectural window films; or
- b) the application of the window film by the dealer does not comply with the manufacturer's instructions and processes; or
- more than one window film is installed on a window or a window film is only partially installed on the glass; or
- the windows are double or triple-glazed and are made of heterogeneous compounds or are structured, laminated, patterned or reflecting or are glazed with wire glass; or
- e) the window film is installed on glass on which there is paint, lettering, stickers or patterns; or
- f) the window film is installed on glass that is obviously damaged, broken or cracked or has drill-holes or other holes enabling light to be seen between the glass and the frame; or
- the window film is installed on plastic, acrylic, polycarbonate or substrates not made of glass; or
- h) the window film is installed in very dirty or coastal areas; or
- i) damages occur or are caused by natural forces (accidents, floods, fires, explosions, terrorism); or
- j) one side of the glass is more than 3.5 metres in length and the surface of doublealazed windows is over 4.64 square metres; or
- k) the window is in shadow due to external overhangs, extensions, pillars etc.; or
- 1) the window has been individually shaped and is larger than 1.8 square metres; or
- m) is of clear float glass thicker than 9.5 mm or of tinted float glass thicker than 6 mm.

The warranty is void if the window film is damaged after installation by incorrect or inappropriate care or treatment, faulty installation, use on unsuitable glass, broken glass, faulty double-glazing or lack of cleaning or care.

The warranty does not cover damages arising from the incorrect or unsuitable treatment of the window film. This particularly applies to scratches due to improper handling.

Installations on more than 1,000 square metres are not recommended. This voids the warranty unless Suntek Europe GmbH has confirmed in writing that the installation is approved.

SunTek Europe GmbH recommends keeping this certificate and the original invoice for installing the window film in a safe place, in order to provide evidence of proper delivery and installation in the event of a warranty claim. To make things simpler we recommend completing the form attached to this statement and presenting it in the event of a warranty claim.
